06 April, from Ku-ring-gai Police Area Command: What would you do? Scenario:

You see a vehicle driving slowly along your street. There are two occupants in the vehicle. They appear to be looking at the houses as they pass. You think they may be up to no good, but they also look like tradesmen who may be looking for an address. There have been a number of break and enters in your area recently and you are suspicious.

What would you do?

- 1. Would you follow them and see what they are up to?
- 2. Would you make note of the registration plate and contact police later that day?
- 3. Would you make note of the registration plate and call police at the time to attend?
- 4. Would you not worry about it at all?

Our CPO's response:

There is no correct answer but there is one that is better for police and for the greater community.

Remember that the scenario described is based on true-life scenarios. It does not contain much detail, which is often the case when we receive a job over the radio. For example, the job broadcast to us may read like this, "A suspicious (Colour of vehicle) vehicle with 2 males on board wearing Hi-Viz shirts" driving slowly, casing out houses in (name of street). Last seen (location) at (time). Not much to go on but it was a start.

The intention here was to provoke thoughts from anyone who was interested in answering.

The answers given possibly reflect that person's experience and this is to be totally expected. Some may have experienced being broken in to and the violation that comes with that. They may look at vehicles being driven down their street slowly wondering if they were the perpetrators in their incident. Others may not be fussed at all. Maybe they haven't experienced a break into their homes. Others may be more cautious and have heard about crime occurring in their area, so they may call us

1. Would you follow them and see what they are up to?

You could do this, and they may tell you, they may simply leave or they may become aggressive towards you, nor do you have any idea of who they are and what they may be intending on doing or indeed capable of doing

2. Would you make note of the registration plate and contact police later that day?

You could do this and while having some detail to go on, if they are people we are wanting to speak with regarding earlier offences, or the vehicle is a stolen vehicle, the opportunity to engage them has been set back.

3. Would you make note of the registration plate and call police at the time to attend?

This would be the ideal scenario for police as you have then given us some basic information at the time to start with. This gives us the best chance to attend and speak with the persons you have a suspicion about. We can then check their bonafides and if legitimate, they go about their business in the area and we get back to the next job. If they happen to be suspects we're looking for then fantastic, we were notified in a timely manner and were able to apprehend them.

4. Would you not worry about it at all?

This is up to you. It may not be anything, but it may be someone who intends to commit a crime in your area. By not doing anything, no one knows for certain. So taking all into consideration, the best answer for us the police, is number 3 and to notify us as soon as possible so we can try to intercept them and check their bonafides.

Thanks for taking the time to think about this and answer. We are here for you the community. We have to work together to keep our community safe.

05 April, from NSW Police Force

A man will appear in court today charged with murder following the suspicious death of a man at Haymarket yesterday morning.

About 3.15am (Sunday 4 April 2021), emergency services were called to serviced apartments on Castlereagh Street, after a man was found unconscious in a hallway on the 13th floor.

Officers from Sydney City Police Area Command found a 43-year-old man unresponsive. Despite CPR being performed, the man was unable to be revived and died at the scene.

A 20-year-old man was arrested nearby and taken to Day Street Police Station.

Police will allege in court the men were involved in a physically altercation in the hallway before the injured man was found unresponsive.

The man was charged with murder.

He has been refused bail to appear at Parramatta Local Court today (Monday 5 April 2021).

Police are not seeking any other parties in relation to the incident.

04 April, from NSW Police Force: Eight injured in boat fire - Brooklyn

Eight people have suffered burns after a boat fire on the Hawkesbury river in Sydney's north this afternoon.

About 5.10pm (Sunday 4 April 2021), emergency services were called to a marina off Dangar Road at Brooklyn, after reports of a boat fire.

Police, ambulance and firefighters attended. The blaze was extinguished; however, the boat was destroyed.

Eight people reportedly suffered varying burns. They are being treated by paramedics and transported to Royal North Shore, Westmead and Gosford hospitals.

No further information is available at this time.

01 April, from Ku-ring-gai Police Area Command

The boating speed limit on our waterways has been reduced to 15 knots!

This speed reduction has been put in place for the Hawkesbury River as far downstream as the M1 at Mooney and commences today, 1st April 2021 with no expiry date at this time.

If you're planning to be out on the water this Easter long weekend and boating along our waterways, please be EXTRA CAREFUL as there are many reports of floating and partially submerged objects which have been swept into the rivers and oceans due to the recent heavy rains and floods.

Some of the hazards you may come across include tyres, large logs, trees and perhaps vessels which have broken their moorings.

If you happen to come across navigational hazards which are or have the potential of being a serious risk to your safety or watercraft, please call the RMS on 131236 who will pass the information on to the local Boating Safety Officer for action.

And remember to wear your lifejackets, ensure the children are wearing their lifejackets, don't drink alcohol while driving or steering a vessel and have your safety equipment in good working order.



06 April, from NSW Police Force

A body, believed to be that of a man missing from Berowra Heights, has been located in bushland today.

The 74-year-old man was last seen at his home in Easton Road, Berowra Heights, prior to 8pm on Thursday 18 March 2021.

Officers from Kuring Gai Police Area Command were notified of the man's disappearance and commenced inquiries into his whereabouts, including an extensive search of surrounding bushland.

A further search was conducted today (Tuesday 6 April 2021), with the assistance of the Dog Unit and a man's body was located on the Berkley Track at Berowra about 11am.

The body is yet to be formally identified but is believed to be that of the missing man.

The death is not being treated as suspicious and a report will be prepared for the information of the Coroner.

05 April, from NSW Police Force

"Draw the line on regional crime" is the central message to the new Regional Crime Campaign being launched today.

In NSW, more than 80% of farmers have reported being a victim of crime according to new research by the Centre for Rural Criminology, University of New England. Even more critical is the high levels of repeat victimisation, with more than 76% of farmers being a victim of crime on more than two occasions, and more than 23% experiencing crime more than seven times*.

Crime Stoppers and the NSW Police Force are launching a state-wide crime campaign today (Monday 5 April 2021) to address awareness of regional crimes, prevention measures and to increase reporting to Crime Stoppers and the police.

Regional crime can affect individual's finances and safety directly but can also have a more widespread impact on the prosperity of the town and its people. In regional areas, the perception of a community, its safety, its people, and its economic situation can affect tourism, impact on its attraction of high-quality health professionals or teachers and other essential service providers. But it doesn't stop there. Crimes in regional areas have a flow-on effect, impacting pricing, distribution, and availability of produce everywhere.

The campaign will provide information on how regional communities can deter or prevent crime in their area while encouraging everyone to report crime. The message to the NSW community is: Any information on any crime anytime. The Crime Stoppers contact centre operates 24/7, 365 days a year and all information captured is in complete confidence.

Minister for Police and Emergency Services, David Elliott, is urging regional residents to report any piece of information no matter how small to Crime Stoppers and the NSW Police.

"It's disheartening to hear more than 80% of our farmers have reported being victims of criminal activity. Our farmers have had a shocking few years with drought, bushfires, COVID-19 and floods – adding victim-of-crime to the mix is reprehensible," Mr Elliott said.

"We're calling on the NSW community to report any information on any crime anytime. If you know something, say something.

"We've seen firsthand the resilience of our farmers, but I draw the line on regional crime."

NSW Crime Stoppers CEO, Peter Price AM, said, "We don't want to know who you are; we just want to know what you know."

"Today we are launching a campaign to draw the line on regional crime. Crime Stoppers is calling for a whole of community approach to draw the line on crime and adopt better prevention strategies and be on the lookout for any suspicious behaviour. The result will be a better, more prosperous future and healthier communities that thrive," Mr Price said.

Crime Stoppers is working with the NSW Police Force Rural Crime Prevention Team and the Police Transport and Public Safety Command across a range of major crime areas including stock theft, marine theft and poaching.

Stock theft, as one example, has a significant financial impact on our farmers. Between 2015 and 2020, there has been a conservative estimated value of \$22.5m worth of sheep and cattle reported stolen within NSW. If we consider the value of stud stock, loss of animal by-products and loss of future breeding potential, the financial impact on primary producers within NSW could realistically be over \$60m*.

NSW Police Force's Corporate Sponsor for Rural Crime, Acting Assistant Commissioner Brett Greentree, says it is important to work together to protect farmers.

"Rural crime has no borders and police across Australia are working together to protect the livelihood of our farmers against offenders who target them," Acting Assistant Commissioner Greentree said.

"Our farmers have already suffered natural disasters such as drought, bushfires and floods and we will not accept people stealing from them or making them feel vulnerable in their own home. We urge you to call Crime Stoppers or your local police with any information."

The theft and poaching of oysters and rock lobster, and the illegal harvest and trade of abalone, is having a detrimental effect on the industry, threatening the

future of legitimate seafood businesses and retailers. It also affects marine resources, tourism and business and can lead to a higher risk of contamination if not processed in accordance with safe food handling practices.

Assistant Commissioner Peter Cotter APM, Commander of the Police Transport and Public Safety Command said crime in the marine space is also leading to an even greater risk to the wider community.

"In many cases, the fabric and economic stability of a country community is associated with its local marine environment. The waterways are kind to us, they sustain us, and they give us food, but it all must be done legally and with diligence to the environment," Assistant Commissioner Cotter said.

"Those breaking the law and fishing without legitimacy or licences are committing criminal acts. It is up to all of us – the community, and the police – to work together, report and disrupt this crime, and ensure the future of the waterways and the prosperity and culture of the community."

The newly-launched community awareness campaign will run state-wide for a 12-month period. Crime Stoppers will be visiting regional communities to engage with communities in an effort to help reduce crime and increase reporting.

Crime in regional areas is not new; however, it continues to be a growing area of concern for the whole of NSW, not just the farming community and therefore it needs a whole of community approach.



Scammers often target people after emergency events such as the recent floods in NSW. They may pretend that they're from a government agency or charity organisation, and will state that they're collecting donations or providing financial assistance and need bank details to transfer money.

Government agencies dealing with flood emergencies do not collect donations through door knocks, emails or over the phone. If you want to donate to assist flood-affected areas, please do so via well-known, registered charities. You can find out if a charity is registered here.

31 March, From the ScamWatch Radar Alert, Australian Competition & Consumer Commission (ACCC)

Payment redirection scams cost Australian businesses \$14 million

Australian businesses reported over \$14 million in losses to Scamwatch due to
payment redirection scams last year, and average losses so far in 2021 are
more than five times higher compared to average losses in the same period last
year.

Total losses are much higher as these scams are reported to a range of different organisations.

In a payment redirection scam, also known as business email compromise scams, scammers impersonate a business or its employees via email and request that money, which usually is owed to the legitimate business, is sent to a fraudulent account.

"Payment redirection scams impact businesses across many industries, including real estate, construction, law, recruitment, and universities," ACCC Deputy Chair Delia Rickard said.

"Scammers tend to target new or junior employees, or even volunteers, as they are less likely to be familiar with their employer's finance processes or the types of requests to expect from their supervisors."

"We recommend organisations ensure their staff are well trained in the company's payment processes and remain aware of payment redirection scams," Ms Rickard said.

Payment redirection scams can take several different forms. In some instances, scammers hack into a legitimate email account and pose as the business, by intercepting legitimate invoices and amending the bank details before releasing emails to the intended recipients.

In one instance, a victim lost \$16,500 in a single transaction after a scammer used a staff member's email address to send an invoice to a customer with 'updated bank details', redirecting the payment to the scammer's personal bank account.

Other times, payment redirection is done by spoofing, when scammers impersonate CEOs or other senior managers using a registered email address that is very similar to that of the genuine email address. The scammer will then request that staff transfer funds to them or make a payment to a third party on behalf of the business.

Scamwatch has also received reports of scammers posing as staff members, where they request the employee's salary be paid into the scammer's bank account.

"An increasing number of reports are coming from sports and community clubs which reported more than \$55,000 in losses to payment redirection scams last year. It is likely we will see similar figures this year, with \$18,000 already reported lost so far in 2021," Ms Rickard said.

Scammers posed as the president or treasurer and requested staff to action payments for 'equipment' or other business needs, but the money went straight into the scammer's bank account.

Other businesses or individuals have also inadvertently paid a scammer as a result of a payment redirection scam.

"It can be difficult to recover money lost to a payment redirection scam, so prevention is really important," Ms Rickard said.

"Don't deviate from your organisation's payment procedure, even if the request you have received appears to come from your CEO or a senior manager."

"If you have received a request that creates a sense of urgency, don't rush.

Take the time to consider and check whether an email is real, including by looking carefully at the sender's email address, before acting on instructions," Ms Rickard said.

"Whenever there is a request to change payment details, always check with the organisation using stored contact details, rather than those in the requesting communication."

If you have been the victim of a scam, contact your bank as soon as possible and contact the platform on which you were scammed to inform them of the circumstances.

From 'Our 20 Favourite Crime Prevention Tips for Car Owners'

Tip #1. WHEN YOU LEAVE YOUR CAR UNATTENDED (even short periods), CLOSE ALLWINDOWS, REMOVE KEY FROM IGNITION & LOCK ALL DOORS. Remember, it's an offence under the Aussie Road Rules to leave your car unlocked.

Tip #2. DON'T HIDE SPARE KEYS ON YOUR VEHICLE. Don't kid yourself—thieves know ALL the best hiding places!

Tip #3. ENSURE YOU HAVE REMOVED ALL PROPERTY FROM VIEW [mobile phone, sunglasses, CDs (burn copies?), bag, wallet, loose change, clothing, laptop, iPod]. EITHER TAKE IT WITH YOU, OR LOCK IT IN THE BOOT. REMOVE ALL SIGNS THAT PROPERTY MAY BE IN THE CAR. eg. no blankets covering tempting lumps on the back seat, no carrier bags.

Tip #6. PARK IN WELL-LIT, HIGH PEDESTRIAN AREAS, PREFERABLY WITH CCTV. AVOID CAR PARKS WITH A HISTORY OF BREAK-INS.

Tip #7.STAY ALERT WHILE APPROACHING YOUR CAR. GET YOUR KEYS OUT OF YOUR BAG READY. DON'T CLICK THE REMOTE CONTROL UNTIL YOU ARE CLOSE TO THE VEHICLE. LOOK AROUND & INSIDE THE CAR BEFORE GETTING IN.

Tip #10. DON'T LEAVE PERSONAL PAPERS SUCH AS LICENCE OR

REGISTRATION IN YOUR VEHICLE. They may be used to dispose of the vehicle. However, do keep with you a note of your vehicle registration & information no. (VIN).

Tip #14. REMEMBER TO TAKE YOUR PARKING TICKET WITH YOU. This makes it difficult for the thief to steal your car.
