Riders will participate in the annual Bobbin Head Cycle Classic from 6.30am in one of 4 events including a 104km, 80km, 57km or 27km ride from Turramurra

through Ku-Ring-Gai Chase National Park and return.

Road and lane closures will be in place between 5am and 3pm along Karuah Rd, Turramurra Ave, Bobbin Head Rd, Ku-Ring-Gai Chase Rd, Pacific Hwy, Mona Vale Rd, Woodbury Rd, Bedford Ave, Warrimoo Ave and General San Martin Dr in Turramurra, Ku-Ring-Gai Chase National Park, Mt Colah and St Ives as cyclists share roads with motorists.

Speed limit reductions will be in place between 6.15am and 12pm along sections of Mona Vale Rd, West Head Rd, Ku-Ring-Gai Chase Rd, McCarrs Creek Rd and Pacific Hwy.

Special event clearways will be in effect in St Ives from 7am to 1:30pm on the eastern side of Mona Vale Rd from Property No.425 to Kitchener St.

Clearways are strict no-parking zones even for local residents and Mobility Scheme Permit holders. Check signs carefully as vehicles left in clearways will be towed and a fee applies.

### 20 March, from Ku-ring-gai Command:

There's been a significant land slip at Galston Gorge which is blocking the road.

Crews face the challenge of moving these three huge boulders weighing 170, 60 and 50 tonnes each!

The Gorge is expected to be closed for at least another week.

18 March, from NSW Police Force: An important message from the Child Abuse and Sex Crimes Squad



Child Abuse and Sex Crimes Squad investigators are reminding parents to be aware of the dangers of online predators, after five men were charged with alleged online grooming offences detected across the state in just over a week. Commencing last Wednesday (9 March 2022), the Child Exploitation Internet Unit (CEIU) executed a number of search warrants in the state's Central West and Southern Tablelands as part of investigations into online child exploitation. Child Abuse and Sex Crimes Squad Commander, Detective Acting Superintendent Adam Powderly, said in each instance police will allege in court

that the men believed they were talking to a child or parent of a child, and expressed desires to engage in sexual activity with the child.

#### 18 March, from Ku-ring-gai Command:

With the advances in electronic communication, criminals don't necessarily need to be face to face to steal from you. Scams are constantly evolving and scammers can go to great lengths to cause people to part with money or information.

Scammers may pretend to be from your bank or a service provider, offer sports betting or short term investment opportunities. They can claim the ability to return owed monies from overseas, often romance and dating opportunities plus numerous other approaches. On the surface these may appear to be genuine.

HERE ARE SOME SIMPLE STEPS TO HELP PROTECT YOURSELF AGAINST SCAMMERS.

IF IT SOUNDS TOO GOOD TO BE TRUE . . .

NEVER send money or give credit card or online account details to anyone you don't know and trust.

ALWAYS seek independent financial and/or legal advice before making any investment or purchasing decisions.

NEVER rely solely on advice from the person trying to sell you the service or investment.

DOOR TO DOOR SALES OR 'TRADIE SCAMS'

DON'T be pressured into signing or paying up front.

ALWAYS research a company or service provider prior to paying or agreeing to a contract.

ALWAYS read any contract or service paperwork carefully prior to paying for any work.

PROTECT YOUR PERSONAL INFORMATION

NEVER give your personal or bank account details to people you don't know and trust.

ALWAYS contact your bank, financial institution or service provider if you have been contacted by a scammer.

DON'T use the numbers provided on the email to confirm an email's legitimacy before replying.

#### DON'T TAKE THINGS ON FACE VALUE

DON'T be fooled by an email that looks legitimate or appears to link to a genuine website.

DON'T open suspicious or unsolicited emails (spam) – ignore them.

ALWAYS beware of 'Cold Calling' and confirm who you are actually talking to.



19 March, from Northern Beaches Command



It began just after midnight this morning with an attempted traffic stop on the Pacific Highway at Roseville.

The blue Mazda didn't stop, instead heading down Boundary Street, over the Roseville Bridge and into Forestville.

It ended with a collision on Warringah Road at Brown Street and a chase on foot to the front yard of a home in nearby Cook Street.

The Mazda driver was taken to hospital for mandatory drug and alcohol tests, then to Manly police station.

There, a 23-year old man was refused bail on charges of:

- police pursuit not stop drive dangerously,
- proceed through red traffic light,
- not give way at lights to oncoming vehicle,
- not give particulars to other driver,
- fail to stop and assist after impact cause injury,
- goods in personal custody suspected being stolen,
- custody of knife in public place subsequent offence, and
- an outstanding warrant.

Conditional bail was granted in court with a second appearance to follow in a fortnight.

18 March, from Traffic and Highway Patrol Command



Officers attached to the Traffic Response Group charge a 32 year old man from Stanhope Gardens with Drive Speed Dangerous following a speed detection of 230km/h at Mount Colah.

On Saturday 12th March 2022 officers were taking part in Operation Upright. The high visibility operation began due to an increase in serious injury and fatal collisions involving motorcycles. About 2:20pm whilst patrolling the Old Pacific Highway between Berowra and Somerbsy officers observed a Yamaha R1 overtaking multiple vehicles across double unbroken centre lines near Hawkebury River Bridge. Officers conducted a U turn but were unable to stop the rider who entered the M1 Motorway using a slip road.

The motorcycle accelerated harshly away from police and was travelling well in excess of 200km/h, officer ceased any attempts to stop the motorcycle due to the extreme risk to the public and rider. Utilising available footage officers were able to calculate the speed of the cycle at no less than 230km/h and no more than 260km/h. Further investigation was able to identify the number plate of the motorcycle.

A 32 year old man from Stanhope Gardens attended Burwood Police Station on Monday 14th March 2022 where he made full admissions to being the rider of the cycle at the time of the offence. The rider further stated he believed he was doing 250km/h and panicked at the time as he was subject to good behaviour conditions on his licence. He was charged with driving in a speed dangerous to the public and exceeding the speed limit by more than 45km/h. His drivers licence was suspended on the spot and the registration plates of his motorcycle seized. He will attend Hornsby Local Court on the 28th April 2022.

Shared with permission from a community group outside of our command. Please note the reference to the Facebook page is of no use now; posts, comments etc have all been deleted.

Hi Everyone,

Just a heads up that the My Macca's app is not secure and a number of people

are having orders made from other states. We lost nearly \$100 from an order made at the Bracken Ridge McDonalds in QLD. Bank can't help because the security in the app itself was breached.

McDonalds don't want to know about it.

There are numerous other people in the same situation, just check out the McDonalds Aust FB page.

Thank you for contacting McDonald's Customer Service.

We are sorry to hear that an unauthorised transaction has been processed with your details.

We are not aware of any security breaches to our systems and are at a loss as to how this fraudulent activity has occurred on your bank account. We would recommend the below:

- We would suggest changing your frequently used passwords immediately. We would suggest doing this for more than the MyMacca's App, as accounts linked to your email may also have been compromised.
- We would suggest you dispute the charge with your financial institution so they can investigate further for you.
- We would also recommend contacting the Australian Government Cyber Crimes unit to report this activity. More information can be found at <a href="https://www.cyber.gov.au/report">https://www.cyber.gov.au/report</a> and https://www.acorn.gov.au/
- If you wish to do so, you can also contact your relevant state police to report the crime and receive a reference number from them regarding the incident.

If you wish to remove your card details on the application, please open the application, and select the 'More' option at the bottom right hand corner of the app. If you then open Payment Methods, you will be able to remove the card that is currently saved there. If you wish to take the step to delete your account, you are able to do so in the previous menu. If you could also confirm the email address linked to your account and the date and location of the unauthorised purchases, we will follow up with our Digital team and arrange for any other users using your payment details to be blacklisted.

We understand that this situation is frustrating, and hope that your financial institution is able to assist in getting this resolved for you.

Child sexual abuse material can be reported anonymously to the eSafety Commissioner at site <a href="here">here</a>.





A 41-year-old man has been arrested and charged with producing child abuse material after officers linked the man to a Kik account.

The AFP-led Australian Centre to Counter Child Exploitation received a report from the United States' National Center for Missing & Exploited Children in September 2021 relating to the upload of child abuse material by a Kik user.

Enquiries by AFP Child Protection Officers allegedly linked the Central Coast man to the Kik account.

The man was arrested yesterday and charged with 18 counts of child abuse-related offences, including seven counts of produce child abuse material. Kik is a free social messaging app where users are identified by a username, rather than a phone number. Users can send messages, video, pictures, and live stream with friends, bots, groups and strangers. Visit <u>eSafety</u> for a Kik safety guide.

# 17 March, from Neighbourhood Watch: St Ives

UPDATE FROM POLICE MEDIA UNIT (the info provided by Lane Cove West Public School had the wrong date)

A police spokesperson advised ITC the following:

"About 8am last Wednesday (9 March 2022), an 11-year-old boy was waiting for a bus on Longueville Road, Lane Cove, when an unknown male approached and offered to drive him to school.

He allegedly told the boy that buses were not operating. The boy declined the offer.

Police were notified and officers attached to North Shore Police Area Command commenced an investigation.

The man police would like to speak with is of Indian Sub-Continental appearance, believed to be aged in his 20s, about 160cm tall, slim build with broad shoulders, and acne on his face. He was last seen wearing a black jumper, black tracksuit pants, black shoes and was carrying a backpack. Inquiries continue."

Note that the police media unit have mentioned Lane Cove Road - Lane Cove ( Lane Cove Road does not go through Lane Cove so we are seeking further info on where exactly this was - Ryde or Macquarie Park) - NOTE POLICE HAVE NOW ADVISED IT WAS LONGUEVILLE ROAD AND WE HAVE UPDATED INFO

#### WARNING FOR PARENTS

The following incident was advised to Lane Cove West Primary School Parents via their skoolbag app yesterday afternoon:


"An 11-year-old boy was approached today at a bus stop this morning in the Lane Cove area. A car pulled up and the driver remained in the car and the passenger got out of the car. He came up to the child and said the school buses were not running and the school was sending Ubers to pick up the kids and take them to school. To his credit, the child refused to get in the car. The man persisted with the story and luckily an adult who was nearby overheard and stepped in. The family involved has reported the incident to the police but wanted to share the story as a reminder to keep the conversation around safety open and ongoing."

The Missing Persons Registry are appealing for public assistance to help locate a Malaysian national missing since late 2020 in Sydney.

Jacky Chong Kai Wong – aged 25 – had been living in Sydney since 2016 and last made contact with a family member in Malaysia by phone on Monday 28 December 2020.

He has not been seen or heard from since and was reported missing to international authorities last August (2021).

The State Crime Command's Missing Persons Registry has since commenced inquiries after receiving notification of Wong's disappearance through Interpol. Initial inquiries to locate Jacky have so far been unsuccessful and police are appealing for anyone with information about his whereabouts or movements to come forward.

Police and family hold serious concerns for his welfare as his disappearance is out of character.

Jacky is described as being of Asian appearance, about 175cm tall, of medium build, and short black hair. He may be wearing glasses. He was last known to frequent the Sydney CBD and Burwood areas.



**Tip #1.** AT THE END OF THE DAY, REMOVE ALL MONEY FROM THE CASH REGISTER AND DISPLAY THE EMPTY DRAWER AS A MESSAGE TO POTENTIAL THIEVES.

**Tip #2.** DO NOT LEAVE YOUR HANDBAG, PHONE, KEYS, ETC BEHIND THE COUNTER. Thieves will distract you, reach over the counter and take your property.

**Tip #5.** INSTALL GOOD QUALITY SECURITY LIGHTS AND/OR SENSOR LIGHTS AROUND THE PERIMETER TO PROVIDE MORE EFFECTIVE ILLUMINATION AT NIGHT.

**Tip #17.** DO REGULAR STOCK TAKES, EVEN HOURLY, IN ORDER TO NARROW THE TIME FRAME OF A THEFT. This enables CCTV to be checked more effectively.

**Tip #20.** ENSURE ALL EMPLOYEES KNOW ALL PHONE NUMBERS & CONTACT DETAILS FOR EVERY KIND OF EMERGENCY. REPORT EVERYTHING THAT DOESN'T APPEAR TO BE RIGHT. Trust your instincts. Warn fellow businesses.
